## It's time for parking permit renewal!

During the month of June each year, residents who hold a CURRENT residential parking permit may get their renewal decal through the TCNA service; those residents applying for a new parking permit must go to the City Parking Authority downtown. Rob Snow has been the coordinator for a number of years and requested to retire from this task. We will miss him and thank him for all of the time that he has spent doing this over the years. Ellen Silbergeld has volunteered to be the new coordinator.

Anyone who has a <u>CURRENT</u> residential permit will be notified by the City to pay the fee for the 2018-2019 on-line. If you renew you permit prior to June 13, Ellen will have your new permit decals for distribution at the TCNA annual meeting on June 13. You can come to Calvert School between 6 and 7 that evening. She will also be available in the lobby of the Colonnade on Saturday, June 16 between 10 and 2. Use the lobby entrance off of Canterbury Road that goes to the residences and not the one that goes to the Inn.

You will need to bring your CAR REGISTRATION to show proof of address. Registration fees must be paid in advanced. (We cannot accept payment)

If you do not pick up your decal on June 16<sup>th</sup>, Ellen has to return the unclaimed decals to the City Parking Authority. You will need to go to the Parking Authority with your registration to pick it from them. If you do not have a current permit, you must go in person to the Parking Authority where you will register and pay for a residential parking permit. Be sure to bring your car registration with you.

# **Zoning Board Hearing: Tuesday, May 29. 1:00PM**

The Zoning Board Hearing is required for Calvert School to build an educational facility on the land at 200-300 Tuscany Road. We have submitted the letter below as part of the agreement between Calvert School and TCNA, The Gardens of Guilford, Tuscany/Lombardy Co-Op, and the Ridgemede/Ridgewood Condos. This hearing is not important for the community to attend. All the groups have agreed to support Calvert in this request.

Re: Case No. 2018-135

Dear Mr. Baumgardner,

We are writing on behalf of the Tuscany-Canterbury Neighborhood Association, the Gardens of Guilford Condominium, Inc., the Tuscany-Lombardy Community Corporation and the Ridgemede and the Ridgewood Condominium Association, Inc. in support of the request by Calvert School for the conditional use for educational purposes of the property in the 200-300 block of Tuscany Road.

33 Warrenton Road was recently subdivided into two parcels, one parcel includes the house and the surrounding 1.04 acres and the second consists of 2.788 acres of wooded land on the northeastern side of the 200-300 blocks of Tuscany Road. Both parcels are zoned R 1 D. The Calvert School is purchasing the wooded parcel along Tuscany Road and plans to use the land for educational purposes and to construct a two-story building with a footprint of 12,000 square feet which will be used as a primary and secondary educational facility.

In February, Andrew Holmgren, Calvert's Headmaster, approached TCNA leadership about his and his trustees' interest in purchasing the wooded property along Tuscany Road and the neighborhood agreed to approach the possible purchase with an open mind. Since then the Associations, have held over 15 meetings with residents to identify concerns and have negotiated terms with the school that are satisfactory to residents of the neighborhood. Representatives of each of the Associations listed above signed an Agreement with Calvert on Friday, April 13.

By signing the Agreement, the Associations have given their approval for Calvert's purchase of the property along Tuscany Road and their support for the use of the property for educational purposes.

## TCNA Streets and Greens Committee Meeting: May 24 7:00 Broadview, Game Room Lower Level

For several years Tuscany-Canterbury has partnered with the Broadview on a variety of projects to beautify 39<sup>th</sup> Street and to calm the traffic between Charles Street and University Parkway. In 2014, the neighborhood approved the overall beautification concept. During the first phase, the Broadview and the neighborhood planted the median strip near University Parkway to prevent pedestrians from crossing anywhere on 39<sup>th</sup> Street and made it safer for everyone.

Originally TCNA wanted to improve the median but could not because of the City's insurance requirements. The Broadview has entered into an agreement with the City to maintain the median and has a broad package of insurance coverage. Last month we reported that the Broadview will be adding several tables and chairs in the median between the Hopkins Deli and the Broadview during the next month.

The Traffic and Parking Committee of TCNA has been renamed and combined with the Gardening Committee – now called the Streets and Greens Committee. Chris Whitaker is the chairperson of this committee. As projects come forward, the committee will call meetings to get input from the community and discuss possible solutions. And then it will find ways to make the projects happen.

This meeting will review the Phase 2 project to help slow traffic between the round-a-bout and University Parkway. If you are interested in this project and want to learn more about it, come to the meeting. A final report will be given at the annual meeting on June 13.
